






Is NSO disability data available in your country?

Respondents whose countries have NSO disability data




Is ministerial (administrative) disability data available in your country?


Is local governmental disability data available in your country?

Is disability data collected by DPOs available in your country?




Respondent ability to download data off of the Internet

Respondent ability to request data from their local and national governments













Comments from participants

Comments from participants aimed at IDA

- Many participants are interested in all of the previously mentioned capacity building activities
- Would be helpful to understand successful advocation of policymakers and to also get information on cooperating with international agencies to advocate governments together
- IDA should offer a PowerPoint or factsheet on where and how to find country data
- Sector specific policy information would be helpful
- It would be helpful if there was a training on data management systems so that accuracy is maintained and used to influence policies for persons with disabilities

General comments from participants

- Agencies should share knowledge and data on disability
- Disaggregated disability data is rarely collected and different data collection methods are being used
- Disability is not only collected on the basis of functionality or definitions
- Proposal: Development of "Gold Indicators" which would be 10 indicators chosen by a broad stakeholder group to measure progress for persons with disabilities
- Proposal: Use of the SEED-SCALE theory. An inclusive self-help group should be established, inspired to run income-generating activities

General comments from participants

- Technical support is needed for African countries to collect and advocate Member States
- Preference for engagement of non-state actors in disability data collection
- Specific measures should be available to encourage people to disclose their disability
- Important to professionalize disability workforce, e.g. those working with and on behalf of persons with disabilities
- There is a need to strengthen collaboration
- Vital that persons with disabilities from all communities are included
- Proposal: creation of a data collection system of organizations of persons with disabilities
