GLOBAL NEWS

• CRPD ratifications reach 111

The ratification of the Convention on the Rights of Persons with Disabilities (CRPD) by Bulgaria on 22 March 2012 brings a total of 111 States Parties to the CRPD, while the Optional Protocol (OP) has 63 ratifications.

The number of signatures to the CRPD is 153 while the OP has 90 signatures.

NEW YORK NEWS

• Commission on the Status of Women

The fifty-sixth session of the Commission on the Status of Women took place from 27 February to 9 March 2012, in New York. The priority theme was 'The empowerment of rural women and their role in poverty and hunger eradication, development and current challenges'. The International Disability Alliance carried out its advocacy activities through contributions towards the resolutions adopted by the Commission on the Status of Women during this session, bilateral meetings and by participating in side events in order to achieve a disability inclusive gender policy in the UN. • Statistical Commission

The 43rd session of the UN Statistical Commission was held from 28 February to 2 March 2012, in New York. The priority theme this year was 'Population and housing censuses'. The Statistical Commission took note of the current and future work programme of the Washington Group on Disability Statistics and IDA made it clear that further in depth discussions

are needed to establish an international methodology for disaggregated data-collection on disability. IDA also recommended that the Commission discuss the issue during one of its annual sessions, preferably in 2014, since the topic for 2013 has been already decided. • Fifth Conference of States Parties

The Fifth Session of the Conference of States Parties to the Convention on the Rights of Persons with Disabilities will take place from 12 to 14 September 2012 at the UN Headquarters, in New York. At this Session of the Conference of States Parties to the CRPD, 9 out of 18 positions on the CRPD Committee will be renewed. IDA has prepared a number of documents to provide information about the election process and to give suggestions and advice to national DPOs on how to influence the nomination process at national level. Partners meeting of the UNPRPD

On Friday 30 March, a partners meeting was held in New York of the UN Partnership on the Rights of Persons with Disabilities (UN-PRPD). The meeting, which was hosted by UNDP, was attended

by a good number of missions to the UN, the six UN agencies that have established the UNPRPD (UNDP, OHCHR, UNICEF, UN DESA, WHO and ILO), as well as civil society organisations. A number of decisions were taken both related to the strategic operational framework and the work plan, including issues related to the composition of the policy board and the management committee. The next step will be to arrange a meeting of the management committee, while it is planned that the policy board will meet during the Conference of States Parties to the CRPD in September.

GENEVA NEWS

Treaty Bodies

The **Committee on the Elimi**nation of Discrimination against Women met from 13 February -3 March 2012 for its 51st session during which it examined the reports of Algeria, Brazil, Grenada, Jordan, Norway, Republic of Congo and Zimbabwe. Together with Brazilian organisations of persons with disabilities (DPOs) and the Latin American Network of Persons with Disabilities and their Families (RIADIS), IDA made a joint submission with respect to Brazil which can be accessed here.

The **CEDAW Committee** held its **Pre-sessional Working Group** from 5 - 9 March during which

it adopted the list of issues on the Central African Republic, Chile, Comoros, Equatorial Guinea, Serbia, Togo and Turkmenistan. • The Human Rights Committee met from 12 - 30 March 2012 for its 104th session during which it examined the reports of Cape Verde (in the absence of a report), Dominican Republic, Guatemala, Turkmenistan and Yemen. On 21 March 2012 (first UN recognised celebration of World Down Syndrome Day), in follow up to the OHCHR study on Article 29 and in particular the recommendation directed to the Human Rights Committee to revise their General Comment no 25 on the right to political participation, IDA, with the support of Open Society Foundations, organised a side event at the Human Rights Committee session to discuss directly with members their role with respect to the political

participation of persons with disabilities. The panel of speakers included: Diane Richler (IDA Chair), Gabor Gombos (independent expert and CRPD Committee member), Shantha Rau Barriga (Human Rights Watch), Maria Alejandra Villanueva (Peruvian self advocate), Oliver Lewis (Mental Disability Advocacy Centre). There was also a video message to the Committee members sent in by Thomas Hammarberg, the Council of Europe Commissioner for Human Rights. For further information on this side event, click here.

Human Rights Council

The 19th Session of the Human Rights Council (HRC) took place from 27 February to 23 March 2012, in Geneva. Click here for further information on this session.

Annual Panel on the rights of persons with disabilities

On 1 March, the Human Rights Council held a debate on the rights of persons with disabilities, which was focused on the right of persons with disabilities to participate in political and public life (article 29 of the CRPD). To support the debate, the Office of High Commissioner produced a thematic study on this topic. Mr. Pat Clarke, President of Down Syndrome International represented IDA on this panel. On the same day (1 March), there was a short concert at the UN by the Finnish rap artist, Signmark, who is deaf, sponsored by Finland in cooperation with the United Nations Office at Geneva (UNOG) and IDA.

Resolution on the rights of persons with disabilities

The Council adopted a resolution on the same topic (the right of persons with disabilities to participate in political and public life), led by the traditional main co-sponsors of the annual disability resolution, Mexico and New Zealand. The resolution recalls that exclusion and restriction of political rights on the basis of disability constitutes discrimination under the CRPD, and calls for a series of measures to ensure enjoyment of the right to participate in political and public life, including recognizing legal capacity on an equal basis with others and providing the support that persons may require to exercise it. Next year, the resolution linked to the rights of persons with disabilities will be focused on work and employment.

Other Resolutions

The following draft resolutions adopted at the session also refer to persons with disabilities: Adequate housing as a component of the right to an adequate standard of living in the context of disaster settings; Mandate of Special Rapporteur in the field of cultural rights; The right to food; Birth registration and the right of everyone to re-

cognition everywhere as a person before the law; Situation of human rights in the Democratic People's Republic of Korea; Human rights, democracy and the rule of law and; Rights of the child. UPCOMING MEETINGS

- The Committee on the Rights of the Child has developed an annotated outline to guide them in the drafting of their upcoming General Comment on child rights and business. The outline is available in English and Spanish. The Committee is now seeking inputs by civil society, including DPOs, on this outline and suggestions on issues to be covered by the General Comment by 20 April in English, French or Spanish. - The Committee on the Rights of Persons with Disabilities will be meeting for its 7th session from 16 20 April 2012 during which it will examine the report of Peru. • The Committee on Economic, **Social and Cultural Rights** will be meeting from 30 April - 18 May 2012 for its 48th session during which it will examine the reports of Ethiopia, New Zealand, Peru, Slovakia and Spain. With respect to Iceland, together with Organisation of Disabled Persons in Iceland (ODI) and the European Disability Form (EDF), IDA made a joint submission, available here.
